# **INVITATION FOR ABSTRACTS SUBMISSION**

The conference invites abstracts for oral or poster presentation at ACPE8 in the area of pharmacoepidemiology and drug safety. Students and researchers from the industry and research institutions are invited to submit their abstracts for presentation and discussion at the meeting.

#### Suggested Topic Areas for Abstract Submission Include:

- 1. Pharmaceutical policy and administration
- 2. Pharmacoepidemiology and pharmacovigilance research methods
- 3. Post-marketing drug effectiveness and safety evaluation
- 4. Drug safety risk monitoring, evaluation and prevention
- 5. Prevention and treatment of drug-induced diseases
- 6. Pharmacogenomics research and drug safety

- 7. Evidence-based practice
- 8. Rational drug use
- 9. Prevention of medication errors and drug misuse/abuse
- 10. Rare disease and orphan medicines
- 11. Drug utilization evaluation studies
- 12. Pharmacoepidemiology and traditional medicines
- 13. Other related fields

All abstracts must be submitted electronically in Microsoft Word format using the on-line submission portal on the conference website, by 30 June2013

#### **Instructions for Preparing Abstracts**

- 1. The abstract must be single-spaced and in upper and lowercase letters (do not use all capital letters). The text must not exceed 250 words excluding title, author details and key words. Abstracts must follow the following format: Aim/Objective, Methods, Results and Conclusion. List not more than four key words related to your research. Tables, graphs, and charts are **NOT** permitted in abstracts.
- 2. Title of the abstract must be in title case. The title should be specific to content. Use short titles and standard abbreviations (expand at its first instance). Include the presenting author's name and affiliation. Avoid reference to institution names, locations, or funding sources in the abstract.
- 3. All abstracts must be submitted in **English only**. Please carefully check all text for errors before submitting, as the quality of your submission may strongly affect the outcome of the reviewers' scoring of your abstract. No edits will be allowed in the submitted abstracts for typing, spelling, or grammatical errors.
- 4. Please indicate on your abstract document your preference for mode of presentation:
  - Oral
  - Poster
- 5. You may select the presentation type you prefer, however the reviewers' decision will be final in this regard.

#### **Abstract Review Process and Presentation**

- 1. In accordance with ISPE policies and procedures, all submitted abstracts will be anonymised as to author and submitting institution, and then reviewed at least three reviewers.
- 2. The reviewers assign accepted abstracts either to oral or poster presentation based on the overall reviewers' score as well as the authors' expressed preference. Notification of acceptance or non-acceptance will be sent by 31 July 2013.
- 3. Only the corresponding author will be notified of acceptance or non-acceptance, and it is corresponding author's responsibility to notify all other authors about the outcome of the reviewers' decision.
- 4. For all the accepted abstracts, the details of oral presentation (PowerPoint presentation) and poster presentation (poster size, format, style and layout etc) will be communicated to presenting authors as appropriate. Abstracts accepted for oral presentation must then submit PowerPoint slides not later than 30 Aug 2013.
- 5. Presenting author must be registered for the conference to be able to present the abstract. All accepted abstracts will be published in the conference booklet only when presenting author registered for conference before 30 Sept 2013.
